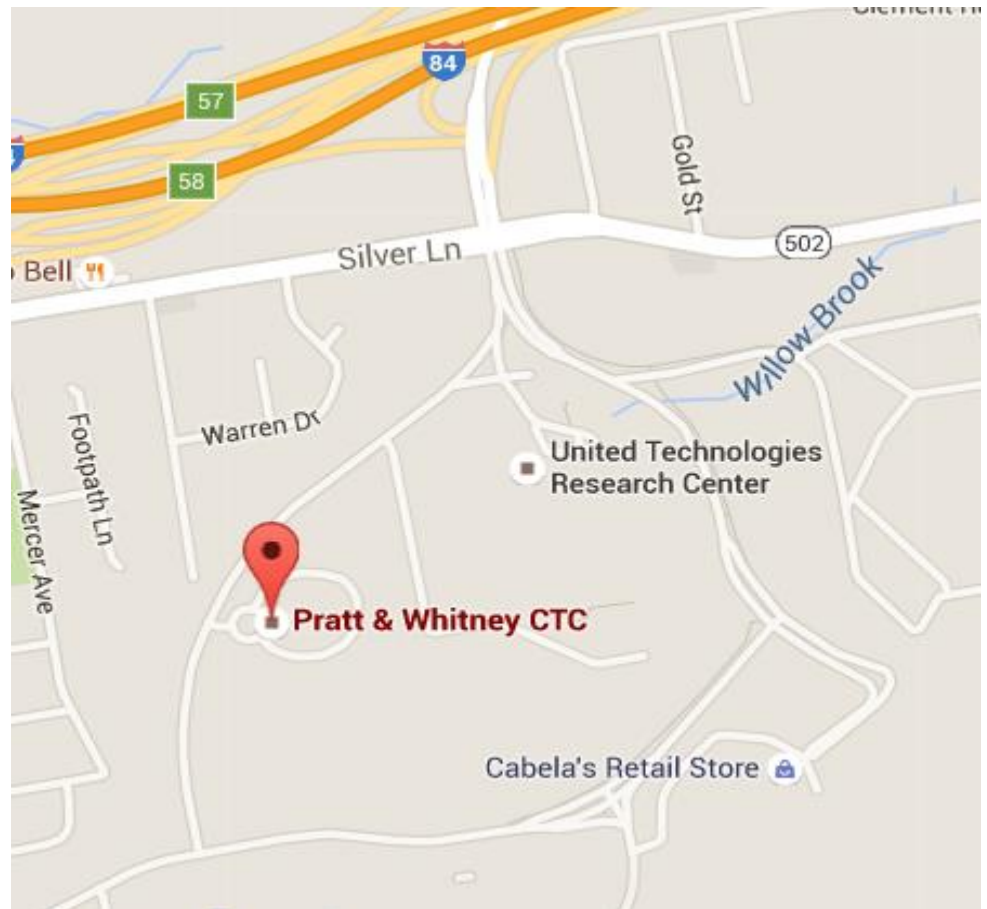

**Secretary's Report:**

**January 2017**

**EAA Chapter 166 Board of Directors Meeting, January 7th, 2017**

Meeting called to order by President Steve Socolosky at 09:38.

Attendees included: Ken Benson, Dave Armando, Jack Hilditch, Jack Olson, Russ Beers, Larry Gagnon, Aaron Gleixner, Mark Occhialini, Greg Prentiss, Joe Gauthier, and Barry Stoner.

Dave reported that exact Chapter figures were not available due to technical difficulties; however, it was estimated that the treasury had about \$4500 and that the membership stood at about 61 of which about 15 have paid the 2017 dues.

Mark reported that the Young Eagles program was another success this year involving about 75 youths; future plans are to continue with flights that will be scheduled again with one in spring and another in the fall.

The EAA Chapter 166 meeting dates for 2017 will be as follows: Jan 29, Feb 26, Mar 26, Apr 30, May 21, June 25, Aug 27, Sep 24, Oct 29, with the dinner planned for Nov 18 and the Christmas Bunch on Dec 9.

Meetings will be at the P&W Customer Training Center; however, another venue is being explored to possibly move the meeting site to the Branford Airport using the Hartford Jet Center Facility - Steve to investigate.

Also, the Holiday Dinner venue is being considered for change to the Flying Monkey to possibly include music - Steve and Dave exploring this.  
Completing the annual corporation registration with the State of Connecticut will be pursued by Barry Stoner.

The need to initiate a Plan for Officer Succession was discussed and an idea to create a new position was suggested, the idea is to have a Co-Lead to follow the President and learn the procedures for Chapter Operations and then eventually move into the leadership position of the President. A candidate needs to be identified for this new assignment. Since nearly everyone has had a turn at President over the years, it was also suggested that it may become necessary to have a second go at it for some.

The topic of finding new members, recruitment, and sustaining the Chapter as we age was discussed at great length. Ideas included holding fly-ins, publicizing events beyond using current methods and scope. Our activities and local presence among new hires at P&W, talking to Radio Control Flying Clubs, etc. Also discussed were outings to include

pancake breakfasts, and hot dog and burger parties at various flying fields such as Skylark and Hartford.

Since the year 2021 marks the 100th anniversary for Brainard Field, this should provide an opportunity for the Chapter to get involved and achieve some visibility.

Another idea was mentioned to coordinate Chapter outings with other Hartford area events to help gain visibility and seek members.

Two of our long term active Chapter members have “gone west;” paperwork has been initiated to honor both these members on the Oshkosh Memorial Wall. Al Cross and Ken Terrio will be honored in this fashion. Joe and Jack working this.

Monthly Program Topics received considerable attention at this meeting with a list of topics presented by Russ and Ken, as well as others.

#### Skylark (7B6)

##### Skylark Airpark (7B6) is open again.

Paving is complete and the runway is operational but pavement markings have not been applied. Please consult your charts for displaced threshold information. Pruning



operations have removed several older growth trees from both ends of the runway. The parking lot has also been paved and is now open. Edge backfilling and landscaping along newly paved surfaces and hangar areas is nearing completion. A self-serve fuel system is in the works but has not yet been delivered. All hangars are full and new (to Skylark) aircraft have begun renting tie downs. Reports on the new surfaces are excellent but the FAA has not yet updated surface conditions at the airport so information providers like AirNav and AOPA who rely on FAA information still show the old “asphalt, in fair condition” status for the runway and taxiway. No news on the replacement fuel farm to report as yet. Repairs on drainage conduits were ongoing during the late autumn and the field is in much better shape after a year of significant improvements. The latest rumor is that additional new hangars and repairs to the FBO building are planned for this summer.

## **Navigation, Performance Flight and Safety Piper PA-34-200 Seneca -Fatal accident October 11, 2016 East Hartford, CT**

The story of this crash was all over the media during October with lots of conflicting stories about what actually happened. According to the Bradley FSDO, this crash occurred during an approach to Brainard (KHFD). The aircraft crashed on to South Main Street in East Hartford near Pratt & Whitney, across the CT River from KHFD. What we know is there were two souls on board, an instructor and a student. The instructor suffered significant injuries and burns but survived. The student perished in the resulting fire. Other than those facts, what is being circulated is hearsay. What we do know so far is the following:

### **FAA Suspends Approval of Certain NavWorx ADS-B Units**

On November 22, the [FAA issued a press release for NavWorx ADS600-B units](#) carrying p/n: 200-0012 or 200-0013. The FAA is concerned that two versions of the company's ADS600-B units, carrying part numbers 200-0012 and 200-0013, may contain an internal Global Positioning System (GPS) chip that does not meet the FAA's minimum performance standards for transmitting an aircraft's accurate location. The AD was issued because NavWorx apparently denied FAA inspectors access to their manufacturing facility on two occasions. The FAA press release refers to an [AD proposed on October 20, 2016](#). The FAA also issued an [Unapproved Parts Notification](#) dated October 14, 2016 in connections to these units.

AOPA has commented on this story and has more information on the issue than the FAA press release. [According to AOPA](#), "The FAA proposed an airworthiness directive (AD) on Oct. 20 that would require removing certain NavWorx Inc. model ADS600-B remote-mounted universal access transceivers (UATs) from the aircraft in which they have been installed, and would prohibit their installation on any aircraft. The products provide Automatic Dependent Surveillance-Broadcast (ADS-B) Out and In on the 978-MHz frequency. The FAA estimates that approximately 800 U.S.-registered aircraft would be affected by the proposed AD." AOPA recommends owners with these units installed immediately cease using them until the matter is resolved.

NavWorx management disagrees with, and responded to, the FAA action in a [statement dated October 17, 2016](#). Stay tuned...

## **Third Class Medical and Pilots' Bill of Rights 2 After a long fight....GREAT NEWS**

As most in the aviation community have already heard, the Pilots' Bill of Rights 2 (PBOR2), including Third Class Medical requirement changes, finally became law as part of the FAA reauthorization bill passed in July. But what does it mean and what is included?

### **Aeromedical Reform FAQs** (Updated: 1/10/2017)

According to EAA's website, "the President signed the medical provisions of the Pilots Bill of Rights 2 (PBOR2) as part of a short-term FAA funding bill on July 15 (H.R. 636, now Public Law 114-190). While the bill is now law, the provisions of the bill do not take effect for pilots until they are written into FAA regulations. The FAA has released the final rule that implements the law.

**The new regulations will go into effect May 1, 2017.”**

**Specters of Meigs Field – Ongoing Battles to Save Our Airports**

**Brainard Airport (KHFD)**

On January 24, 2017, AOPA published an article about the CT Legislative Committee study findings called “[Report backs Connecticut airport](#)” by Jim Moore. It essentials says that the legislative committee “tasked with studying the potential closure of Hartford-Brainard Airport has recommending that the state instead increase investment in the facility, and the jobs and workforce development that it supports.” Does this mean that attempts by various special interest groups and their political friends to close the airport and convert it to other uses will cease? Of course not! Various groups have had their eyes on Brainard for decades so local aviation stakeholders must remain vigilant. This skirmish appears to have been won but there are forces at city hall and the state capitol who are determined to grab this local resource for non-aviation purposes. **Santa Monica temporarily stops airport evictions amid federal investigation**

Developers and politicians in the city of Santa Monica, CA have been trying to get their hands on one of the oldest and most historic airports in California. [The FAA stepped in, following an attempt by the city to evict aviation businesses, temporarily halting the city’s illegal actions but the fight is not over by any means](#). Santa Monica’s effort is a larger venue version of what developers and politicians in Hartford are trying to do with Brainard. This is a time to be very wary of forces that covet local airports. Former Hartford Mayor Eddie Perez, MDC chairman Bill DiBella, current Mayor Bronin and various developer friends have tried to seize control of KHFD by increments several times. They attempted to close the crosswind runway, brought pressure to close CT Aero Tech and other initiatives yet to be discovered. Please keep your eyes and ears open for signs that something is afoot. Their avarice is not going away. [AOPA, NBAA and others are watching this closely and weighing in on it](#).

At age 70, Ken decided to do something different. He evolved from restoring antique cars to building an EAB, the [Pober Ace Jr](#). He got his pilot’s license and spent many hours flying in the open cockpit with his wife, children, grandchildren and anyone who wanted a ride. Always the perfectionist, he was soon recognized within the trade, taking part in aircraft building clinics and volunteering at EAA AirVenture OSH with his wife Helene.. Ken later restored a Stinson 108 Voyager, which was finished after he was diagnosed with his illness, and helped Chapter 166 bring the EAA B-17 Aluminum Overcast (above) to Hartford.
